Jacky graduated from the Social and Economic Sciences Faculty of Geneva University, with a major in Geography, and then later on from the Psychology Faculty.

After meeting Jean, she decided to go with him to AECC and then Los Angeles Chiropractic College in 1977. They were married in 1970 and their daughter, Sophie, was born in 1974.

She started her own practice in Switzerland after graduating, and held a number of influential posts in the Swiss Chiropractic Association, including President of the Geneva Canton from 1989 to 2006 and Vice President of the Association from 1993 to 2001.

Together with Jean, she organised the 1996 Convention in Geneva – The Puzzling Relationship of Vertigo and Cervical Spine – and it was predictably a great success.

As well as her love for her profession, she had great enthusiasm for the house in France – where she and Jean spent their free time and holidays and hosted the annual meetings of the ECU Research Council – and for buying antiques to furnish it. She was an accomplished cook, and loved history and art.

Her family, friends and colleagues will remember Jacky as a strong, energetic and determined woman. She was the engine of our friend Jean! She will be very sadly missed.

# Supporting the standards of the profession

The statement below will appear as part of an article in the next issue of Dynamic Chiropractic. It is being published following an exchange of correspondence between the ECU/WFC and Dr Tedd Koren in relation to his teaching of non-chiropractors in Germany

TEACHING OUR profession to non-chiropractic therapists of any kind dramatically lowers our levels of education and credibility and creates a dangerous two-tier profession where patients and State Authorities will be fooled by all non DCs.

With people having this type of behaviour, although being informed months before the event, it is obvious that all the profession worldwide must be united to avoid any similar event in Europe or elsewhere. Dr Koren has provoked this reaction. That was certainly not his ultimate goal ... but why does he need to teach less-educated non-chiropractic professionals? Is it too simple for DCs ... or is there any other reason?

Philippe Druart DC, FAECC(Hon), FBCA(Hon), FFEAC ECU President ECU wants to thank WFC which has totally endorsed its position. We will always fight any similar problem to the one initiated by Dr Koren!

A list (the 'Alert' list) has been drawn up of those who flagrantly contravene ECU requirements, mainly based on ECCE standards. This is supported by all the National Associations within ECU and those on the list will not be welcome to speak at any event sponsored or organised by the member nations of ECU.

- Collecting data in practice settings

# High standards in European chiropractic conference

The man who helped develop the academic programme for the 2007 ECU Convention and WFC Congress, **Vassilis Maltezopoulos DC**, **MD**, **FFEAC**, presents an overview of the event.

TH R'S convention, entitled *Celebrating the Past, Present and Future of Chiropractic*, was indeed a great celebration for our profession, especially as it was held in conjunction with the 9th Biennial WFC Congress and it coincided with the 75th anniversary of ECU.

The academic programme itself was a big success and a celebration of chiropractic art, science and philosophy. More than 700 delegates from all over the world gathered in sunny and picturesque southern Portugal, to attend this highly educational and scientific event for European chiropractic and to listen to the 25 invited speakers and renowned personalities of the scientific community. Leading figures from both the chiropractic and medical worlds, including Scott Haldeman, Jaime Guzman, Fred Carrick, David Cassidy, Alan Breen, Bruce Lipton, Craig Morris and many others, put their hearts into some very inspiring lectures and workshops that outlined the past, present and possible future directions of chiropractic.

There were different categories of lectures and workshops: many clinical and scientific presentations, a lot on technique, many on chiropractic philosophy, some on sports chiropractic and imaging diagnosis, on chiropractic education, even on the history of chiropractic with the launch of the newly-published book on European chiropractic history, by Francis Wilson (see page 27).

One of the most important highlights of the Convention/
Congress was the report on the findings of the Bone and Joint Decade Task Force on *Neck Pain and Related Disorders*, led by Scott Haldeman, which was given for the first time in a chiropractic conference and will be published in *Spine* and *European Spine Journal* in November.

Also, the tradition of presenting named chiropractic techniques that began at the Cyprus convention and continued last year in Stockholm was again repeated in Vilamoura. The techniques presented were Chiropractic Neurology, Activator Methods, BEST, Gonstead, End Range Loading, Orthospinology, and Extremity Adjusting.

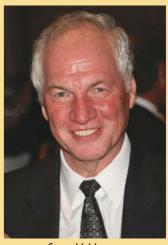
Great emphasis was once again placed on the presentation of original research, with over 100 papers accepted for platform and poster presentation. Prizes for best research were awarded both for work carried out in research institutions, and from private practices. The prestigious Scott Haldeman Award (USD 7000), first prize in the original research competition out of the 38 papers

that were given floor presentation, went to a Dutch research team, led by Sidney Rubinstein, for a paper entitled *Predictors for Adverse Reactions Following Chiropractic Care for Patients with Neck Pain*, a great distinction for European research! See page 12 for a summary of this paper.

Special mention must be given to a two-and-a-half hour, very inspiring lecture, given by Bruce Lipton PhD, on the morning of the last day. It was entitled A New Biology: Lessons from Cell Biology about our Environment and the Future of Health, Wellness and the Chiropractic Profession, which gave us an insight into the application of quantum physics in cell biology, its implications in the understanding of health and disease, and its relation to the origins and evolution of chiropractic.

Overall, the event in Vilamoura, apart from being very successful and enjoyable, has set high standards in European chiropractic conferences, an example to be followed in future conventions.

### **Dedication and hard work**

Organising a convention in Portugal is, in some ways, rather easy, according to **Phylactis Ierides DC**, the ECU's Convention Administrative Organiser.

VEN THOUGH the APQ is one of the smaller chiropractic associations of the ECU, it succeeded in hosting an event of record-breaking numbers. This is partly because the organisers decided to initiate an effort to increase participation, for present and future conventions, by reducing the registration fee for young chiropractic graduates and chiropractic students to below cost.

The initial task in finding an ideal location in Portugal for the ECU 75th Anniversary Convention and the WFC 9th Biennial Congress was rather easy for the organisers. The final decision was for Vilamoura, in the Algarve, one of the largest

single tourist areas in Europe, and considered by many to be a unique leisure and recreation resort. The venue, Tivoli Marinotel, is a five star hotel situated on a small peninsula, where on one side is the Atlantic Ocean and on the other a fascinating marina. Naturally the hugeness of the event created certain difficulties for the organisers, but all were handled with dedication and hard work and the ECU/WFC team worked tirelessly throughout the event. Thanks go to Linda Sicoli (WFC) and Beth Anastassiades, now employed by the ECU in Cyprus. The multitude of conference rooms made the scheduling easier, when dealing with concurrent lectures,

The featured speaker was Professor Joao Lobo Antunes, Portugal's leading neurosurgeon, from the University of Lisbon, who spoke on the future of health care in Europe and his positive clinical experiences with the growing chiropractic profession in Portugal which was recognised by legislation in 2003.

Another factor contributing to the success of this huge event is the continuing support from our sponsors and exhibitors. As many as 60 exhibitors representing 26 companies participated – more than at any past events. Let me take this opportunity to thank them, as well as the lecturers, sponsors and above all our delegates.

# Winner of the Scott Haldeman Award

**Sidney Rubinstein** presents the results of the paper which won first prize — the **Scott Haldeman Award** — in the WFC's original research competition.

UR STUDY, Predictors of Adverse Reactions Following Chiropractic Care for Patients with Neck Pain, is the second paper written on data we collected in the Netherlands on patients with neck pain, visiting the chiropractor for the first time. The study design was a prospective, multi-centre cohort. Patients completed questionnaires prior to the first visit, at the first few subsequent visits, and again at 3 and 12 months. We describe negative reactions the patients experienced in the course of treatment. The chiropractors also completed questionnaires, firstly concerning themselves (eg age, sex, institution of chiropractic education, years of experience), and also on the treatments they administered, including type of technique used (eg Gonstead, Activator, diversified, soft tissue). Through the application of advanced statistical modelling, (multilevel multivariate logistic regression analysis), we sought to identify those factors, related to the patient, (eg age, sex, work status, duration of neck pain) or related to the chiropractor (eg where educated, gender, experience) or related to the treatment (eg techniques, number of attempted adjustments to the cervical spine), which might correlate with the development of adverse symptoms following treatment.

In all, 79 chiropractors participated and recruited 529 subjects. Most patients had chronic, recurrent complaints, mild to moderate disability, and a mild amount of pain at baseline. The majority of the chiropractors were male, had followed a European chiropractic education, and worked full-time.



Applying the multivariate logistic regression models we discovered that the following were predictive of any type of adverse reaction:

1) the (reported) use of a manipulative technique involving rotation to the cervical spine

2) patients on sick-leave or on workers' compensation

Patients with longer duration of neck pain were more likely to have a specific type of adverse reaction, namely headache and/or increased neck pain.

A few other items were also predictive of adverse reactions, but with a weaker level of evidence. These were: European chiropractic education, headache or neck disability prior to commencing care, and intermittent pain on presentation. Interestingly, a visit to the general practitioner prior to visiting the chiropractor was less likely to result in an adverse reaction.

It should be noted here, that in the course of this study approximately 5,000 treatments were conducted, and that no serious, lasting adverse events occurred. For further information on this data, see *Rubinstein et al. The benefits outweigh the risks for patients undergoing chiropractic care for neck pain: a prospective, multicenter, cohort study. JMPT 2007, July/Aug edition.* 

# Chiropractor experience not a predictor

Interestingly and paradoxically, we had expected that variables related to the chiropractor or the treatment, such as years of experience, or type of technique used, or degree of disability in the patient, might predict certain types of adverse reactions. However, despite the fact that a large number of variables were examined, only

three variables consistently came up, as listed above.

The reported use of rotation was found to be a predictor of adverse reactions. However, the techniques which, in the cervical spine also include rotation, such as diversified and Gonstead, were **not** predictive of an adverse reaction. Only when the practitioner specifically indicated that rotation had been used, was a weak to moderate association found.

# What does this mean for the chiropractorpatient encounter?

A major strength of this study was the use of multilevel modelling which takes into account the effect of clustering of patients by any given chiropractor. This means that the results of this study can better be generalised to other practices. We know from this and other studies that patients are more prone to adverse reactions in the early stages of treatment. Therefore these should be taken into consideration, particularly in the initiation of patient care. Besides the association with rotation, it is of interest to note that adverse reactions were more associated with patient characteristics rather than with the chiropractor or the treatment. This implies that certain patients are more prone to adverse reactions than others.

I would especially like to acknowledge my colleagues: Prof Maurits van Tulder, Prof Charlotte Leboeuf-Yde, Tammy de Koekkoek, Charles Pfeifle, and Dirk Knol. Without their assistance, this would not have been possible.

The article has been accepted for publication in JMPT and should appear at the end of 2007/beginning 2008.

### The way forward for chiropractic

In his address to the World Federation of Chiropractic Assembly of Members, **Øystein Ogre** gave his opinions on the way forward for the profession.

IN SYDNEY two years ago I could report that the Norwegian Parliament had voted for a new law giving the Norwegian chiropractors extended rights. These rights were:

- Partial reimbursement for chiropractic treatments for all patients
- The right to sick-leave patients
- The right to refer patients to hospital, to a medical specialist and to physiotherapy.

We have also made progress in two other areas:

- 1.5% of the total reimbursements given for patients is now being put into a postgraduate education fund
- The government decided to pay the chiropractors supervising our graduates who are doing their one year mandatory internship

Before we were given the new rights, the medical association tried to tell the public that if chiropractors were given these rights, a lot more people would end up being on sick leave and the chiropractors would overload the medical specialists with unnecessary referrals. None of this happened. On the contrary; given these responsibilities, chiropractors have acted in a most conscientious way.

Chiropractors in Norway just do what they were trained to do, being primary health care physicians acting in relation with other health care workers in the best interest of their patients. I am both happy and proud to report to you that they do it as if it were the most natural thing in the world.

Our next and primary goal now is to establish a university-based

education on Norwegian soil. We know that we have support for it in the Parliament and we are convinced that we will succeed with it within a few years.

The WFC's Consultation on Identity process was a great success. With it, the WFC showed that it can be influential in the development of chiropractic world wide.

In my opinion there are now three other areas that need to be addressed. The first, and most important one is organisation. If we take a closer look at countries that have succeeded when it comes to achieving proper laws and regulations, making chiropractic well known to the public and overall creating good conditions for chiropractors to practice, there are some common factors. One of them is that they were all very well organised. Therefore I challenge WFC members to work out a strategy with the objective of getting the chiropractic world better organised.

The second area is **recruitment**. There are a few countries in the world where chiropractors are numerous and chiropractic is well-known to the public. But in most countries this is not the case. What we see in Europe, and also on other continents, is an increased number of people practising in competing professions like osteopathy, naprapati or manual therapy. I have seen many examples of small associations working hard to get chiropractic licensed and at the same time forgetting to address the main problem which is the lack of chiropractors in the country. When you are only 20 chiropractors in a country with

15-20 million people, the health authorities are likely not even to bother to take a closer look at the profession.

It is my belief that we should have a strategy to recruit more chiropractors from countries that struggle to grow in numbers. This is especially true in former east-Europe. We cannot be satisfied having only a handful of chiropractors practising in former

east European countries. Rivalling professions will outstrike us. We must think larger numbers and I ask the WFC council to lead in this work.

The third point of attention that I would like to speak about is **membership support**.

To make political progress for this profession we need somebody who is able to address our issues of attention. And that somebody is the national chiropractic associations. We need to create a better understanding among chiropractors; they need to be aware of the fact that unless we are properly organised, we will not have any proper impact facing the authorities. Unfortunately, what we see today in many countries is poor membership support. I believe that we have to create an understanding among all chiropractors and all chiropractic students of how important it is to support your own profession by joining the chiropractic associations and standing together. One for all and all for one.

What the chiropractic world needs is leadership. I believe that if we address these issues we can make a tremendous difference.

What we don't need is to focus on things that separate us as chiropractors. Wellness vs evidence based practice, straights vs mixers, lengthy discussions on the interpretation of the subluxation complex etc, etc.

Wouldn't it be nice if we could just be chiropractors; caring for our patients, caring for our colleagues, caring for our profession and just be chiropractors working for a common goal with WFC leading the way?

### Straighten Up

A campaign to highlight the fact that back pain is often related to poor posture is gradually being launched throughout the world. Straighten Up America was first developed by a team at Life University. Now Straighten Up has been launched by several other countries; the first European launch was in the UK.



THE BRITISH Chiropractic Association (BCA) used its Chiropractic Awareness Week (CAW) to introduce the campaign during April 2007, and it achieved tremendous results in a number of different areas; member

participation, press coverage, general public response and web-based response. Thousands of requests for leaflets resulted from the press coverage, and about 25,000 are now in circulation in the UK.

The BCA will continue to promote *Straighten Up UK* at a national and local level. The base promotion materials are available to member associations of the ECU and a special ECU *Straighten Up* website is being developed. A new website will also be dedicated to *Straighten Up*, to enable other chiropractic and non-chiropractic organisations to use its messages.

The Netherlands Chiropractors' Association is already taking steps in that direction; it is in touch with the BCA, translating the folders and PowerPoint presentations, and is aiming to run local events

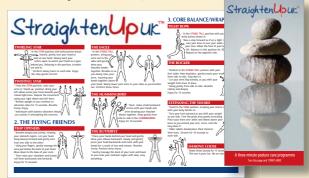
throughout the Netherlands next year. It hopes to include a larger event, with the financial and/or moral support of the Bone and Joint Decade group.

The Swedish Chiropractic Association has taken its first steps towards *Straighten Up Sweden* by translating the exercises into Swedish and sending them out to its members with an explanation of the campaign aims. Prior to this, two board members did pilot

projects in their cities to see the response from schools, by going out to show the exercises to children and teachers. When the schools start after the summer break, Swedish members will be encouraged to do the same thing all over Sweden, aiming for a launch on World Spine Day, 16 October.

The Finnish Chiropractic Association has contacted the BCA too, and aims to run *Straighten Up Finland* in the week before its 30th anniversary in November.

Successful re-accreditation is to be followed by the first graduation of the AECC's new curriculum. **Ken Vall DC**, principal, is delighted with progress.

THIS YEAR the AECC has had re-accreditation visits from both the UK's General Chiropractic Council (GCC) and the Council on Chiropractic Education – Europe (CCEE). I am pleased to say that both these accrediting bodies reported favourably on the AECC. In fact, we received no conditions for accreditation, which is possibly a first for any chiropractic institution in Europe.

A lot of hard work goes into achieving such success and I would like to extend my gratitude to all involved.

We are this year graduating the first cohort of students of our new curriculum and it will be very interesting to see how these graduates will be received by the profession. The GCC commended us for "innovation in the patientcentred curriculum" and the CCEE listed as a strength "the development and refinement of the new curriculum, which is perceived by students and staff as a success". Our aim has been to produce better, more reflective practitioners, who are more confident with resolving uncertainty.

This June the AECC was able to agree a way ahead in helping the Maria Cristina College in Spain to establish a five-year degree course in chiropractic. We are now looking forward to seeing the first cohort of students start this October. The development of chiropractic in this area of Europe is dependent on having good education locally and I am pleased to see the support given to this venture by both the Spanish Association and the ECU Council.

We are now drafting our next strategic plan and, perhaps for the first time, this is done from a position of strength. We have ambitious plans and we will achieve



more if we have the full support of the chiropractic profession in Europe and particularly from the AECC graduates. I would therefore like to remind graduates that we have our next homecoming event on 8 September here at the College. The academic event will focus on sport with two excellent speakers: Jean-Pierre Meersseman from Milan and Ross McDonald from Edinburgh. You are all welcome and I hope to see many of you in September.

#### The New AECC Clinic

We have now received planning permission from Bournemouth Borough Council for the building of a new fit-for-purpose chiropractic clinic on campus. # Multidisciplinary opportunities at WIOC

The Welsh Institute of Chiropractic is providing wide-ranging opportunities for students and practitioners, reports **David Byfield**, Head of the Welsh Institute, University of Glamorgan.

THE WELSH Sports Medicine
Centre at Glamorgan, which
will initially be housed within the
WIOC, was officially opened in
March by Mr Alan Pugh AM,
Minister for Welsh Culture,
Language and Sport. It was attended
by many university staff and students
as well as Dr Peter Dixon, Chairman
of the General Chiropractic Council,
Dr Dik Skippings, Chairman of
the College of Chiropractors Sports
Chiropractic Faculty and Dr Ulrik
Sandstrøm, President of the British
Chiropractic Sports Council.

This new initiative will provide the chiropractic programme with an in-house multidisciplinary opportunity to develop new working relationships and learning modes with a clear teaching and research link for our students. In the process, it will provide postgraduate prospects for the profession.

The launch included a multidisciplinary sports medicine meeting held over two days, involving surgeons, physiotherapists and chiropractors looking specifically at lower limb related functional

disorders. This meeting was attended by a large cohort of chiropractic students who did the profession and programme proud with their participation and level of questioning. This will be an annual event.

#### **MChiro degree**

The chiropractic division was involved in a university wide validation event in April, to explore the possibility of replacing our existing BSc Honours Chiropractic degree with an undergraduate Master of Chiropractic (MChiro) degree. The validation panel considered documentation, received considerable external input from both professional and academic colleagues and questioned the academic development team on the rationale and implementation of the new degree. I am very pleased to announce that the validation panel approved the new MChiro degree for a five year period commencing September 2007. There were a few minor conditions but our new intake in 2007 and our current year 1 and 2 students will automatically transfer to the new degree programme. The validation team complemented the quality of our documentation and teamwork in the formulation of this new degree programme.

### Financial assistance for students

The Welsh Assembly continues to support Welsh-domiciled students and provide them with a grant of £1800 towards their top-up fees which means they continue to pay only £1200 as opposed to the £3000 elsewhere in the UK. This programme has been extended to non-UK EU students who will be classified as Welsh domiciled and eligible for the same £1800 grant towards their tuition. This provides significant financial assistance to students considering a career in chiropractic from countries within the European Union. The important issue here is choice for students selecting an accredited institution for their chiropractic education that gives them mobility after graduation to return to their country of origin to begin

# First chiropractic students to study at University of Zurich

**Bea Wettstein Meichtry**, head of education at the Swiss Chiropractic Institute, describes how new legislation in Switzerland has brought changes for chiropractic students.

HIROPRACTIC EDUCATION in
Switzerland is going through a big change. As of September 2007 the chiropractic profession will be included in the new law on medical professions together with MDs, dentists, pharmacists and veterinary surgeons.

Under this law chiropractors in Switzerland are accepted as medical personnel on a national level. The new law will regulate undergraduate, postgraduate and continuing education and its implementation necessitates some adaptations.

In autumn 2008 the first chiropractic students will be able to study at the University of Zurich.

Postgraduate education will still take place at the Swiss

Chiropractic Institute in Bern. Dr Martin Wangler DC was its last director, until the end of July 2007, after which the school has been going through a reorganisation to simplify its procedures and to adapt to the new regulations for chiropractic education.

The department of education will be divided into different sub-departments (graduate, postgraduate, continuing education, accreditation and research). Each sub-department has its own director and is supervised and coordinated by the head of education.

We are very excited to be able to offer chiropractic education at a Swiss University in 2008. Together with the postgraduate programme in Bern we guarantee a high quality of chiropractors.

### World Federation of Chiropractic (WFC)

**Barry J Lewis DC CCSP FCC FFEAC**, European Region Representative, updates us on world chiropractic issues.

AJOR ACTIVITY within WFC since I last wrote includes the recent elections for all regions of WFC. As you will probably be aware, the European Region qualified for two representatives and, following nominations and subsequent elections, Dr Espen Johannesen (Norway) and I were selected to represent Europe on WFC Council for the next three years from the WFC meeting in Vilamoura.

Recently, the Brazilian association (ABQ) came under some pressure with the local physiotherapists claiming chiropractic to be a speciality of their discipline. There is currently no law governing our profession in Brazil - although one is 'in the pipeline'. This is an important issue because if Brazil 'falls' there may be a follow-on effect in other Latin American countries due to a precedent being set. The British Chiropractic Association responded to a call from WFC for funds to help Brazil in their fight for the right to an independent profession and the ECU has sent a donation. The Danish and Norwegian

Chiropractic Associations have also offered a substantial sum and a number of others within ECU have since offered to help out. The ABQ is a small association, mainly recent graduates, and it seems appropriate that those of us who are well established with our own regulation should offer assistance if at all possible.

The Vilamoura Convention (WFC/ECU) was the largest WFC Congress ever held with many attending from within Europe itself. During the Congress we welcomed two major guests to the podium. Dr John Sweaney - a former President of WFC - gave the initial John A Sweaney Lecture entitled Chiropractic: In Pursuit of Professionalism. This excellent address was received with a standing ovation by those attending the WFC Assembly. He was immediately followed by Dr Karen Shields Wright who introduced Sister Brigitte Yengo, DC MD who works in the DR Congo with orphans and provides a home, sustenance and health care for them and the local community. A fundraising event at the Congress

raised more than US\$7000 for her charity. I must say that it was a bit daunting to be one of the speakers following on from these two charismatic people who have given much to both the profession and the wider community.

Generally, the Congress was a great success. The Portuguese gave us a very warm welcome – in both substance and temperature – the venue was marvellous and the

speakers were very well received. This will go down as one of the great successes and it was a major achievement for the ECU in presenting itself to the world on its 75th anniversary.

#### Case to remember

### Riedel's lobe

**Lee Ayres** is reminded of the importance of maintaining and improving upon general diagnostic skills

#### **Presenting complaint**

A 56-year-old nurse presented to our clinic complaining of right buttock pain travelling down the posterior thigh to the knee. Over a period of 48 hours this pain progressed to cover the right posterolateral calf and ankle.

#### History

The patient described how she had suffered a similar episode six months previously, although this had eased off over a two week period despite receiving no treatment. Pain levels were aggravated by prolonged standing and walking and the patient was able to find little relief despite being prescribed diclofenac and diazepam. No bowel or bladder dysfunction was present.

#### **Examination findings**

Physical examination showed the straight leg raise to be reduced to 45 degrees on the right and reproduced the patient's right buttock pain. All the musculature in the right gluteal region was very tender to palpation and pressure in this area referred pain into the mid posterior thigh. The patient was having difficulty with all position changes which limited a number of the orthopaedic tests. Sensory, motor and reflex testing was within normal limits bilaterally.

#### **Working diagnosis**

From the history and physical

examination a working diagnosis of right piriformis syndrome was reached, although a lower lumbar disc protrusion was considered as a differential.

#### **Treatment**

Treatment was undertaken which included spinal manipulative therapy of the lumbar spine and pelvis, and soft tissue work and myofascial dry needling to relax the surrounding musculature. After a period of eight treatments over four weeks the patient was failing to demonstrate significant improvement. Due to this failure to respond to conservative care an x-ray was taken of the lumbar spine and pelvis.

#### A-P x-ray of the lumbar spine and pelvis

As the x-ray shows, there are mild degenerative changes in the lumbar spine although not sufficient to account for the patient's pain. More significant on these films is the increased area of opacity. This begins approximately 2cm above the right iliac crest and diverges towards the vertebral body of L2 medially and the rib border laterally. In the middle of this radio opaque structure there are two unfortunate artefacts, which can therefore be clinically ignored. From the position and shape of this structure the immediate inclination was

to search for other signs and symptoms that may point towards enlargement of the liver.

Some of the symptoms associated with enlargement of the liver can be vague, like loss of appetite, weight loss and lethargy. The patient was experiencing lethargy and loss of appetite although she had been experiencing high levels of pain over the preceding three week period which could have contributed towards this presentation.

A closer examination of the patient's abdomen revealed that the liver was palpable and this was supported by percussion around the same area. Fortunately the

liver was found to be smooth, uniform and non-tender which, alongside the x-ray, made a primary hepatoma or secondary tumour unlikely.

More obvious signs that would point towards liver disease such as jaundice, bruising, spider naevi or ascites were not present. This posed the question, why was there an increase in the size of the right lower lobe of the liver? And, was there a link to the pain that the patient was experiencing into the right leg?

An absence of any conclusive signs that would support enlargement of the liver led to the consideration of a congenital explanation. Riedel's lobe is a

tongue-like accessory lobe of the liver that is related to the inferior portion of the right hepatic lobe. This is thought to be quite a common finding during medical imaging of the liver and some studies have shown that it can occur in up to 19.4% of female patients (Baum et al.). Despite the fact that this is considered to be a common congenital variant it is noticeable by its absence from a number of medical textbooks.

Finding any potential link to this congenital variant and the patient's leg pain proved more difficult. There are no previous documented cases linking the two although considering the apparent regularity of this variant within the general population it may be worth further investigation.

### Reasons to remember this case

The most important lesson that I gained from this case was the importance of maintaining and improving upon general diagnostic skills. Patients presenting with lower back and leg pain are everyday occurrences for chiropractors, and consequently it is possible to become flippant with the diagnostic procedure. Abdominal palpation is something that was not initially performed on this patient and would have added to an overall picture.

Although the structure found on the patient's x-ray is probably not contributing towards her leg pain, it was important to identify it in order to send the patient for further testing. After only two years as a qualified chiropractor I felt that I may have already developed a tendency to view patient's presenting symptoms in isolation. This case highlighted the opportunity we are presented with every time a new patient walks into our treatment room. We have the time and the education to provide them with a thorough evaluation of their overall health, and this should not be wasted.

#### Book review

# Evidence-Based Chiropractice Practice

#### Michael T Haneline

Karl Devriese reviews this new publication.

HIROPRACTIC MAY not be best or good enough for any and every patient who walks through the door in any and every situation, even when the red and yellow flags have been eliminated. The intensity, the frequency and the type of care should be in sync with the latest research findings and the patient's wishes. What we say and how we say it, our body language, empathy and attitude should also be the subject of critical 'inter-' and/or introspection and reflect what has been published in the literature about this.

The fact that our patients honestly lie (termed acquiescence) is a sad consequence of the relationship that a patient used to have with his doctor. Patients should not have to worry about building the self-image of the doctor. The doctor

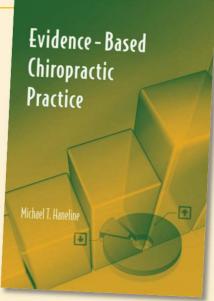
as an advisor, a teacher, a coach, should cope with this possible misunderstanding from the first and especially the second encounter on, by inviting and encouraging the patient to reveal the bad news as well as the good news, if any.

Your world as a doctor doesn't fall apart when the patient has an adverse reaction, and when you don't judge the patient, the patient may not constantly judge you. Let the patient feel that it is not about you (I am talking to myself, believe me). The relationship between the doctor and the patient, depending on each individual's perception, can balance between judging, blaming, 'weighing' personalities as in an argument, or empathising, trusting, feeling recognised, supporting, actively listening and exchanging the relevant pieces of

information in the right amount as in a constructive relationship.

To simplify, tell the patient you will not be offended by (almost) anything they say and tell them you also need to know about the 'bad' news for optimal care. Don't forget to ask patients as a matter of routine what they want, so you can accord the violins and work on common goals. Being assertive is not synonymous with being aggressive. Being assertive means that you can also tell the truth to the patient when he doesn't seem to comply or when he has a prejudiced attitude. It also means you can refuse treatment and refer, or stop an ongoing treatment in case of poor results.

As chiropractors we should go with the flow of information, preferably and mainly based on the strongest possible evidence we have



from systematic reviews, metaanalyses of randomised controlled trials, whenever possible. Sometimes it will be based on nothing else than expert opinion, or least, on no evidence at all.

#### The irony of it all

Most of what I will write about in this article will, ironically, be based upon my point of view. The funniest sentence in the whole book, to me, is a very ironical one as well: "It should be noted that Evidence Based Practice itself has

not been rigorously tested, so we do not know for sure if it actually results in improved health". We have no evidence that applying the evidence we do have, will result in improved health. This is almost an existential, philosophical statement. This book is far from humorous or philosophical however, so forgive me for sitting back and relaxing for a moment in order to better face reality.

Our practice, as well as any other practice in health care, is still founded on loose ground in general. This, however, does not give us a free ticket to disconnect from reality and the evidence we do have. We keep in mind that not being able to show evidence of effect is not synonymous to having evidence of no effect, let alone evidence of harm. No proof of a positive, significant difference in efficacy could imply that the treatment is no better, but also no worse than the other treatments that were studied. That can be very positive news when taking any possible side effects into consideration in comparing treatments.

# Implementing evidence based chiropractic

The differentiation between background and foreground information is an interesting one. Background information concerns broad knowledge about the condition at issue regarding its anatomical and pathophysiological basis and foreground information will lead to the best diagnostic and treatment strategies for the involved patient. Background information is necessary before dealing with matters in the foreground. Books are generally a good source of background information; articles generally deal with foreground questions. Unfiltered information is retrieved from the original journal articles; filtered information comes from expert reviews of all available original articles on a given topic. The first step in obtaining evidence is to look at the prefiltered information

because much work has already been done. The disadvantage may be that the reviewers may be biased because of their educational and/or philosophical background. Foreground questions are more complex than background questions to compose.

A correctly formatted clinical question (PICO) is composed of defining the problem at hand or the type of patient(s) abbreviated as P.

The letter I concerns the intervention

very useful chapter on the types of evidence referring to an extensive list of possible sources, within and outside of chiropractic.

# Practical applications of Evidence-Based Chiropractic (EBC)

There could be 'internal' and 'external' reasons for implementing outcome measures, suggested as a form of EBC. The outcome measures for 'internal' reasons are meant to

reimbursement. Probably the best way to deal with the suggestions for EBC in such a case is just to ask relevant questions personally, in the context of the Activities of Daily Living (ADL). The patient appreciates the personal touch when you ask the questions yourself, one on one.

For third party reimbursement and 'external' proof of efficacy and monitoring progress I could not think of any better way to go than to have patients fill out these questionnaires.

I consider the pain scales or the grading method very useful for monitoring progression and I ask the patients to estimate their progression in percentage terms, after about four weeks of treatment.

# Another interesting concept is patient-oriented evidence that matters (POEMS)

or exposure that is being considered. Letter C is optional and stands for comparing treatments with the primary intervention. Letter O represents the outcome of interest preferably patient-relevant versus doctor-relevant outcomes.

Another interesting concept is patient-oriented evidence that matters (POEMS). The outcome of the investigated matter should be something that patients are expected to care about. The studied problem should be widespread and the intervention involved should be feasible. The information should have the potential to change the practice of many practitioners.

Disease oriented evidence (DOE) deals with the outcomes that may be of interest to researchers and practitioners but are of little interest to patients. These so-called surrogate outcomes are not actually capable of determining whether a given treatment works, but may provide evidence as to how it works. An intervention commonly has positive effects on surrogate outcomes but not on clinically relevant outcomes.

### Where is the information?

Reading the chiropractic literature is not sufficient. This book has a

demonstrate and to convince the patient and the doctor that there is progress and it should have a positive impact on patient satisfaction and compliance. The outcome measures for 'external' reasons are meant to demonstrate progress to convince third-party payers.

Monitoring patient progress is an entirely 'internal' issue in Belgium, for the moment. My experience with the use of some of the questionnaires mentioned is not a good one. Some patients actually found the questions to be irrelevant or difficult to answer because of the limited options offered. The questions are usually very general and consider a wide range of disability degrees; therefore some patients with minor symptoms seemed to feel they were perhaps dramatising. In such a case, there is usually also a problem with responsiveness.

A positive change is less likely to be quantifiable. The patients with major symptoms, on the other hand, were rather annoyed when they had to fill out these forms and they had the feeling they were wasting time. Also, they preferred to be questioned in a customised manner. So, I don't use questionnaires any more at this time, until I have to change my mind again, based on new information or for third party

#### Conclusion

I have suffered through this book but I appreciate the genuine effort of the author to organise this information on a theme that I nevertheless consider to be very important. It was of limited practical use for me to read it from front to back but a few chapters caught my attention.

Going through the routine of formulating clinical questions and the method of browsing through the literature is well described. The chapter on documentation and putting it all together is very important but too limited and of minor importance when there is no third party reimbursement to claim for. The appendices contain a wealth of information for English speaking readers but the questionnaires cannot just be translated into different languages because changing a word or a meaning of a word has an important influence on the validity.

### Chiropractic in Europe

CHIROPRACTIC IN

Europe provides a valuable introduction to chiropractic's history from a European perspective. It has been written and published to commemorate the 75th anniversary of the European Chiropractors' Union.

Twenty-three authors contribute important historical data and information about chiropractic practice today. The reader will discover many documents and pictures unknown to the general public, some of which are being published for the first time, that tell the fascinating story of chiropractic from its origins in the United States in the last years of the 19th century, to contemporary times.

Special reference should be made to the selection of photographs that cover, in a different way, the long history of chiropractic in Europe.

The book comprises two sections. The first part provides an overview of chiropractic's history from a European perspective, while in the second section the history of chiropractic in 19 European countries is examined.

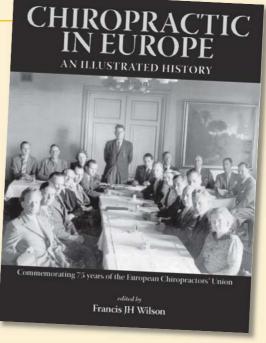
Section One sheds light onto unknown details of chiropractic history in Europe but it also goes as far back as the origins of chiropractic in the United States. Special reference is made to the European pioneers. A section is devoted to the 75 years of the European Chiropractic Union - the formation of the Union and the pre-war years up to the latest news and developments. The reader will be surprised to discover that until October 2006 the total number of chiropractors in the European Chiropractor's Union did not exceed 3,200 and almost half of them were located in Great Britain.

But the European Chiropractors' Union is confident about future prospects. As it is noted in the book, "Although the chiropractors of Europe remain a relatively small group in relation to their counterparts across the Atlantic, chiropractic in Europe is thriving and the number of chiropractors practising in Europe is growing exponentially".

In Section Two, each story covering chiropractic in the 19 different countries includes important key facts for each country, such as the number of chiropractors registered, population etc. Written in a style that a nonspecialist can fully comprehend, each chapter revives

important moments of chiropractic's history and the memory of pioneers of chiropractic who contributed

significantly to the progress of their science and to public health and quality of life in their countries. The reader will discover that chiropractic is still an innovation for certain countries and is yet to be fully recognised.

The book will be of particular interest to chiropractors and chiropractic students and is written in a way that can prove to be an enjoyable reading experience for non-specialists and anyone who has an interest in learning more about chiropractic. It also represents a valuable source of information for historians.
